Our 2019-20 season featured five productions, including two commissioned premieres, two large-scale musicals, and an international presentation. Our season began with the arrival of Circus Abyssinia: Ethiopian Dreams to the Twin Cities, a leading center of circus training as well as a center of East African migration. CTC commissioned longtime collaborator Greg Banks to create a two-actor adaptation of Snow White, which brings a surprising twist to the titular character's fate. Returning for the holiday season was our beloved production of Cinderella, starring brand new acting company member Rajan Katurah. January welcomed the new musical, Bob Marley's Three Little Birds, based on a book by the late musician's daughter, directed by Sha Cage. The season's second world premiere was Philip

CTC's Neighborhood Bridges programs served students and classroom teachers in grades pre-K-5 this year through in-depth school residencies; community residencies and workshops; and professional development opportunities for educators and caregivers. During the 2019-20 school year, Neighborhood Bridges continued a major expansion to incorporate 18 new Somali Muslim stories into its curriculum. To gather these stories Neighborhood Bridges staff and teaching artists are interviewing high school students who identify as Muslim at Minneapolis's Wellstone International High School, as well as participants in Augsburg University's East African Student to Teacher program. Through this new curriculum, we hope to give Muslim students the opportunity to see themselves and their community represented in

CTC's Theatre Arts Training program (TAT) provides instruction in storytelling, acting, dance, voice, directing, and playwriting for young people ages 2-18. In addition to sequenced classes during the school year, Theatre Arts Training also offers summer and other school vacation camps for students at all skill levels and programming for homeschool groups designed to meet their educational goals TAT also includes the Pre-Professional Institute, which provides high school students with an intensive, four-year, conservatory-style learning experience. The Senior Company program provides students with demanding material that seeks to challenge them as artists, educate them in a professional setting, and inspire them to be active voices in their community. TAT has also expanded its reach in the community, ensuring

The coronavirus pandemic closed the Theatre venue on March 13, 2020 for public performances which significantly reduced the Theatre's ticket sales and other earned revenue during the year that ended June 30, 2020. The Theatre took immediate measures to reduce costs and to maintain adequate liquidity. The continuation of the spread of the virus has caused a rapidly changing business environment, unprecedented market volatility, and other circumstances that will continue to impact its business in future periods. The Theatre continues to monitor evolving economic, public health, and general business conditions to address the actual and potential impacts on its financial position, results of operations, and cash flows. The Theatre has made significant reductions in operating expenses to reflect the inability to conduct live, in-person performances by eliminating non-essential spending where feasible.

Before The Theater was forced to shutter the venue, 91,748 individuals attending the public performances came from 600 cities and towns in the Midwest and 76 out of 87 Minnesota counties. A total of 41,155 students and their teachers attending weekday matinee performances came from 129 cities and towns, mostly in Minnesota.

more needs-based scholarships are available for all classes. TAT's Virtual Academy was launched in May 2020. This program offers online TAT classes for young people. Virtual Academy classes are tailored to the strengths of a digital creative experience with a blend of online and self-paced learning, group activities and individual coaching, independent creation, and opportunities for full family engagement. Students joined from 30 states and 3 countries for creativity, collaboration, and artistic exploration. A total of 137 young people registered for Virtual Academy classes in June 2020, including 10 in "Digital Performance: Pride."
